#### 5. INSURANCE

#### 5.1 Insurance cover with FMSCI Permit

Competitors: A maximum of 250 competitors with valid FMSCI Competition License participating in various events across the Country on a given day are covered for Personal Accident Insurance for Rs. 5 lakhs with Rs. 1 Lakh medical expense extension per person.

Officials: A maximum of 100 officials officiating in various events across the Country on a given day are covered for Personal Accident Insurance for Rs.25 lakhs with Rs.5 lakhs medical expense extension per person.

All competitors must possess a valid high-risk insurance with hospitalization benefits preferably a cashless policy for a minimum of Rs.10 lakhs.

# 5.2 Exclusion of Insurance Cover

The Service and Reconnaissance vehicles, even those bearing Special Plates supplied by the organizers are never considered as official participants of the Rally Sprint. They are therefore not covered by the Insurance Policy of the Rally and will remain the sole responsibility of their owners.

#### 5.3 Accident Reporting

If a driver taking part in a rally is involved in an accident in which a member of the public sustains physical injury, the driver concerned must report this to the next radio point as specified in the road book and signposted on the route according to Article 53 of GP. If he fails to observe this rule, the Stewards may impose on the crew responsible, a penalty which may go as far as disqualification. The laws of the country must also be complied with in relation to procedures at accidents.

#### 5.4 Rally Cover Insurance for Competing Vehicles

The competing vehicles must possess **Rally Cover Insurance valid from 18-Jan-25 to 19-Jan-25.** 

#### 6. ADVERTISING AND IDENTIFICATION

### 6.1 Competition Numbers, advertising and Driver's and Co-Driver's names

These will be in accordance with Articles 27,28 & 29 of the **2024** FMSCI General Prescriptions for Stage Rallies and Art.8 of Specific Regulations for INRC.

# 7. TYRES

# 7.1 Tyres Specified for use during the rally

Tyres shall confirm to Appendix IV of FMSCI General Prescriptions.

# 8. FUEL

Free as per **2024** Technical Regulations for Rallying.

# 9. RECONNAISSANCE

#### 9.1 Procedure for Registration

Crews must report to Rally Headquarters for registration prior to commencing reconnaissance. They must submit details of the reconnaissance car.

Each crew will be issued with two vehicle identification cards which must be displayed on the top of the co-driver's side of the front windscreen and on the co-driver's rear side window during reconnaissance, and a pass valid for up to ONE passage over the special stage. This pass must be carried in the reconnaissance vehicle, shown to and endorsed by an official at the start and finish of the special stage during reconnaissance.

# 9.2 Specific and /or National Restrictions

- **9.2.1** For all competitors, reconnaissance will be carried out in accordance with the FMSCI General Prescriptions with a maximum of 1 pass over the stage in accordance with the reconnaissance schedule given in Appendix II.
- **9.2.2** Reconnaissance outside the schedule will be considered a very serious offence and will be reported to the Stewards who may apply sanctions.
- **9.2.3** Reconnaissance will be conducted strictly in accordance with the published schedule. No late entry into a stage for reconnaissance will be permitted.
- **9.2.4** Maximum speed allowed on all special stages during reconnaissance is 45 Kmph.
- **9.2.5** Crews must have the vehicle headlamps switched on while traveling on special stages during reconnaissance.

- **9.2.6** Crews are only permitted to enter a special stage from the start points shown in the road book and will NOT under any circumstances drive in a direction opposite to that of the rally sprint, unless instructed by an official of the event.
- **9.2.7** Crews must stop at the Start and Finish (and other locations where instructed) of the stage where rally official will endorse the crew's reconnaissance pass card.

#### 9.2.8 Penalties for excessive speed

Refer Art. 34.2 of the **2024** FMSCI General Prescriptions.

# **12. OTHER PROCEDURES**

# 12.1 Start Procedure - Special Stage

Manual start procedure - after handing the time card back to the crew, the start marshal will count down aloud: 30" - 15" - 10" and the last five seconds one by one. When the last 5 seconds have elapsed, the starting signal shall be given.

# **12.2** Official Time used during the Rally

Official time to be used during the rally will be that of GPS time (GMT +5.30 Hrs). This will be given at the time of Driver's Briefing.

# 12.3 Start Area

Before the start of the competitive element of the rally, the organisers may assemble all the competing cars in a starting area, into which cars must be driven before the start time as detailed in the supplementary regulations. The exclusively pecuniary penalties for late arrival in the starting area shall be Rs.1000/= per minute. No service is allowed in the start area.

Any crew reporting more than 15 minutes late at the start of a section shall not be allowed to start that section.

# **15. POST EVENT SCRUTINY / FINAL CHECKS**

A representative of the entrant as well as mechanics with appropriate tools (in case of dismantling) must be present at the final check.

# 16. PROTESTS & APPEALS

# **16.1 PROTESTS**

The protest fee is Rs.18,000/= + 18% GST. Total Rs.21,240/= for National Championship

If the protest requires the dismantling and re-assembly of different parts of a car, the protestor must lodge an additional deposit. The additional deposit for a protest involving a clearly defined part of the car (engine, transmission, steering, braking system, electrical installation, bodywork, etc.) Rs. 11,800/= (including GST) per part.

The expenses incurred for the work and by the transport of the car shall be borne by the claimant if the protest is unfounded, or by the competitor against whom the protest is lodged if it is upheld.

If the protest is unfounded, and if the expenses incurred by the protest (Scrutineering, transport, etc.) are higher than the amount of the deposit, the difference shall be borne by the claimant. Conversely, if the expenses are less, the difference shall be returned.

Note: all fees are inclusive of taxes applicable in India.

# **16.2 APPEALS**

Appeal Deposit: Rs.96,000/= + 18% GST. Total Rs.113,280/=

Competitors may appeal against decisions, in accordance with the stipulations set out in Articles 15.1 of the Code.

*Competitors, Drivers* or other licence-holders that are addressees of a stewards' decision or that are individually affected by such decision, whatever their nationality, shall have the right to appeal against that decision before the *ASN* of the country in which it was given. They must however, under pain of forfeiture of their right to appeal, notify the Stewards of the meeting in writing within one hour of the publication of the decision, of their intention to appeal.

The right to bring an appeal to the FMSCI along with the Appeal deposit expires 96 hours from the moment the stewards are notified of the intention to appeal on condition that the intention of appealing has been notified in writing to the stewards within one hour of the publication of the decision.

This appeal may be brought by fax or by any other electronic means of communication with confirmation of receipt. Confirmation by a letter of the same date accompanied by the necessary fee is required. The FMSCI will give its decision within a maximum of 30 days.

All parties concerned shall be given adequate notice of the hearing of any appeal. They shall be entitled to call witnesses, but their failure to attend the hearing shall not interrupt the course of the proceedings.

The confirmation of an appeal to the FMSCI must be accompanied by a deposit of Rs.96,000/-+18% GST. Total Rs.113,280/=.

This fee becomes due from the moment the appellant notifies the Stewards of the intention of appealing, and remains payable even if the appellant does not follow up the declared intention to appeal.

If the appeal is rejected or it is withdrawn after being brought, no part of the fee shall be returned.

If judged partially founded, the fee may be returned in part, and its entirety if the appeal is upheld.

If it is proved that the author of the appeal has acted in bad faith, the FMSCI may inflict upon them one of the penalties laid down in the Code.







All competitors, officials, volunteers and any others involved in any capacity in motorsport, under the aegis of the FMSCI is expected to comply with the FMSCI Sustainability Guidelines.

# **Sustainability Guidelines**

# **Guidelines**

#### 1. General Principels

1.1 All Clubs, Organisers, Promoters, Teams affiliated to the FMSCI shall adapt their statutes in order to give proper prominence to the organisation of sustainable events and to the principles in the FMSCI Sustainability Guidelines.

**1.2** Where local regulations or legislations are stricter than those contained in the FMSCI Sustainability Guidelines, then the local requirements must be followed.

1.3 Wherever an event is held, it is mandatory for the organisers to connect with an authorised/ licenced vendor of that particular municipality/ corporation for proper disposal of segregated waste.

1.4 Organisers must indicate the actions taken for the final disposal of waste.

1.5 Organisers must provide drinking water points.

#### 2. Sustainability Officer

All events run under the FMSCI, must appoint a Sustainability Officer.

The Role of the SUSTAINABILITY OFFICER:

- Have access to all information concerning the event.
- Enforce and manage the sustainable initiatives at the event.
- Create new sustainability initiatives and improve existing ones.
- Engage the various groups involved in the event to inspire change and create legacy.
- Make a report based on the checklist drawn up by the Sustainability and Environment

Commission of the FMSCI. and send it within 48 hours to the FMSCI. Failure to do this will attract

suspension from these duties.

- In case of any observation on non-compliance of the FMSCI Sustainability Guidelines, the

Sustainability Officer must provide details, in writing, to the COC and the Official Secretary of the

event.

# **3. Protection of the Ground and Biodiversity**

- a) Measures must be taken to prevent leaks of fuel, oil, cleaning, degreasing, cooling, and brake fluids, etc. into the ground.
- b) Containers/facilities to recover rubbish, oils, detergents, etc. must be provided.
- c) Provision must be made for the treatment of spillage and the disposal of contaminated material, by the organisers.
- d) It is strictly forbidden to empty on to the ground waste liquids from vehicles and catering facilities located in the / scrutineering/ service areas/any other. Waste liquids may only be disposed of at the circuit if the organiser has provided a proper facility to allow this.
- e) Do not leave on the spot permanent evidence of any motorsport activity.
- f) Consider using sticker rolls instead of individual stacks.

# **3.1 Protection of Ground**

It is advised to use an Environmental mat composed of an absorbent upper part and an

impermeable lower part or other effective and approved system to prevent soil and water

contamination at events.

a) wherever work on 2w /4w is allowed.

b) In the Parc Fermé.

c) in the Pits, under generators or anywhere that there is risk of spillage of oil, fuel, effluents.

d) At official refuelling points.

# **3.2** Protection of biodiversity

When organising events in or near vulnerable areas take into account the protection and promotion of biodiversity. Consider the potential impacts on biodiversity for a temporary event

such as a rally in setting the route.

### 4. Obligation of the participants / team members

a) Each participant and/or team member is responsible for the waste generated by his team during the event.

b) Where organisers provide the necessary containers for waste, they must be used as directed.

c) Waste must be retained by the team until the approved facilities provided by organisers can be

used.

d) Used tyres must be retained by the teams or manufacturers unless storage and disposal facilities

are provided by the organisers.

e) Paper cups and single use plastic including bin liners, unless compostable, is strictly forbidden.

Teams are encouraged to bring water cans/ bottles of 25 litres and reusable water bottles.

f) These recommendations, duties and obligations must be mentioned in the Supplementary

Regulations and referred to at the Briefing.

#### 5 Sound Level

a) All unnecessary running of engines must be avoided.

b) Minimising excessive noise from public address systems is the responsibility of the clubs,

organisers and all officials.

c) Awareness messages on environmental behaviour can be broadcast on public address systems

at approved decibel levels.

#### 6. Sustainable Transport

It is advised to use transportation to the events that are sustainable in nature, to reduce the travel and freight carbon footprint. Following are the measures suggested to do the same:

- a) Using Public Transport
- b) Developing a culture of carpooling
- c) Optimizing event logistics; viz. remote operations, local sourcing of workforce, creating re
  - usable and multi-year infrastructure
- d) Defining efficient routes, in terms of minimizing travel distances between events.
- e) Promoting sustainable fuels for competitions.
